Item 1 Call to order and Land Recognition	Chair of the board welcomed all to the meeting and called the meeting to order at 1008 PDT. Field Hockey Canada respects and acknowledges the First Nations/Indigenous, Inuit, and Métis peoples of Canada as the Keepers of the Territories upon which we will be meeting today. I am residing in Mi'kma'ki, the ancestral and unceded territory of the Mi'kmaq People. <i>Field Hockey Canada acknowledges that its office resides on the uncended territory of the Coast Salish Peoples, including the territories of the x^wməθkwəy̓əm (Musqueam), Skwxwú7mesh (Squamish), Stz'uminus, Stó:lō and Səlilwəta²/Selilwitulh (Tsleil-Waututh) Nations.</i>

Item 5	Safe Sport FHC legal counsel, Will Russell, provided a brief presentation of FHC's Safe Sport process, which addressed issues such as: • Role of the Independent Third Party and external panel • Policy limits regarding disclosure. • Publication of decision summaries by FHC and Abuse-Free Sport/OSIC. He answered general questions from FHBC and FHO related to the FHC Safe Sport process. i. Sport Integrity Alignment Working Group FHC is forming a Working Group to identify areas of improvement and address jurisdictional elements within the field hockey system in Canada. This includes consideration of consistent conduct standards, reporting mechanisms, cost effective adjudication process and reciprocity agreements between national, provincial/territorial and community field hockey organizations. FHC will circulate the draft Terms of Reference to the Members. FHC has requested that Abuse Free Sport conduct a Sport Environment Assessment to identify areas of improvement for the organization. FHBC identified their concerns regarding recent Safe Sport activities. FHO, FHQ and FHA echoed this sentiment.
Item 6 Nominations and Elections	Formal appointments were endorsed as follows: Candidates who have completed their first term and are seeking re-election for the second term: Krissy Wishart (as Athlete Director) and Ben Martin (as Athlete Director) MOTION: To re-appoint Krissy Wishart (as Athlete Director) and Ben Martin to Field Hockey Canada's Board of Directors for a second term. Noting Krissy and Ben appointed by the athlete group. MOVED BY: Denise McGeachy, British Columbia SECONDED BY: Sajjan Jabbal, Field Hockey Alberta RESULT: Passed, all in favour Terry Lockhart, Kerry Moynihan and Ronald Prins were appointed to the board in March 2024 after an open application process. The board will comprise 6 directors moving into the new season. FHQ noted the board is relatively new. FHC highlighted the need to recruit according to the skills matrix and gap analysis. The board will be seeking gender equity and diversity as well as to fill HR and legal gaps as it moves into the new season.
Item 7 Reporting: Chair Report HR report Governance Report	Chair Deb Whitten referred to the reports from the standing committees of the board which were circulated to the members in accordance with the bylaws prior to the meeting. There were no questions from members.
Item 7 Reporting: Treasurer's Reports	The Audited Financial Statements, and Financial Reporting were provided in advance of the meeting. Treasurer Terry Lockhart led the members through an informative presentation of the financial statements, highlighting it was a clean audit process and sees FHC in a position of relative financial strength having started this strategic cycle in a deficit. The organization now has unrestricted net assets that it will be able to make decisions around their allocation. Terry Lockhart noted that although his surname is the same as FHC's auditors, they are unrelated and there is no conflict of interest. MOTION: To accept the audited financial statements as presented.
